• Elizabethton Star Advertising Presentation: Lynn Richardson, Publisher of the Elizabethton Star, stated she has researched pricing and found that the Elizabethton Star is priced higher than the Johnson City Press for legal notices. She said the Star will match the Johnson City Press's pricing of 11.5 cents per word. Ms. Richardson also said the Elizabethton Star has a circulation rate of 10,645 in Carter County. Commissioner Danny Ward asked how many papers are returned daily. Ms. Richardson said approximately 600 unsold papers are returned. Chairman Lyons said he thinks of the Elizabethton Star as a hometown newspaper and would like to see the County use them if pricing is brought back down. Mayor Humphrey said the circulation rate of the Elizabethton Star versus Johnson City Press in Carter County warrant advertising with the Elizabethton Star.

Motion was made by Danny Ward, second by Charles VonCannon to advertise with the Elizabethton Star. All ayes, motion carried.

New Business

Bid Limit: Interim Director Christa Byrd provided the committee with documentation showing that the State
of Tennessee has authorized local governments to increase their bid limit to \$25,000 and quote limit to
\$10,000. Captain Croy and Captain Smith discussed how increasing the bid limit would be beneficial to the
Sheriff's Department.
