Members Present: Joel Street, Pat Hicks, John Lewis, Charles VonCannon, Buford Peters, Sonja Culler, Bobbie Dietz, Tom Bowers

On a motion from Mr. VonCannon with a second from Mr. Lewis both the minutes from the February meeting and the agenda were approved 8-0.

- Director's Report: The ramp at the recycling center is in need of repair. Since the long term use of the current facility is uncertain, Mr. Lyons said that he intended to remove the damaged concrete and replace it with crushed gravel. If this solution does not adequately address the problem, we may have to concrete the ramp. Mr. Lyons reported that our roll-off truck has engine problems and is in the shop. We are currently using a truck on loan from Edwards Company, but they may need it back before our truck is repaired. A motion was made by Mr. VonCannon and seconded by Mr. Bowers to grant authority for Mr. Lyons to contact other local governments to see if they might have a truck that can be loaned. Should this effort fail, Mr. Lyons will explore the possibility of renting a roll-back truck. The motion passed without opposition on a voice vote.
- Unfinished Business: Mr. Lyons reported that attorney Bowers is working on recycling hub agreements with Elizabethton and Watauga in order that we can apply for the recycling hub grant.
 - Mr. Lyons reported that we did not secure the bid to remove Elizabethton's solid waste. However, the city is rebidding for this service. CTAS representatives will help us put together a new bid.
- New Business: Don and Kay Woods requested that we sponsor recycling during Covered Bridge Days. Mr. Street reported that we have had discussions with the city and the sheriff's department, and we should be able to do this. If feasible, we will also put out recycling cans for the car shows. The committee commended Mr. and Mrs. Woods for their efforts in promoting this project.

Mr. Lewis raised the question of how many tires a citizen might take to the landfill in a given year. Mr. Lyons reported that the policy is to receive no more than eight per year from an individual. Any beyond that must be taken to the recycling hub at Bowser Ridge. Mr. Street used this as an opportunity to inform the committee that changes to tire recycling will take place in July of this year. The state will send back to the county money from the tire disposal fees paid in Carter County, but tire dumps will then become the responsibility of each county. The state will help with large dumps, but the term large has not yet been defined. Prior to then a decision will have to

made in regard to whether we are to stay in the tire hub. Mr. Street indicated that there are currently many unknowns. Information will be shared with the committee as it becomes available. Ultimately, the future of the tire hub is in the hands of the mayors of the participating counties.

Mr. Von Cannon mentioned the possibility of collecting plastic bottles and aluminum cans at local golf tournaments. Benny will contact Danny Hilbert and Mr. Von Cannon will contact representatives of the golf course.

There being no additional business, Sonja Culler moved for adjournment, and this received a second from Buford Peters. The vote was 8-0 in the affirmative.
