The Chairman called the meeting to order and welcomed everyone in attendance. Roll call - quorum met.

5. <u>Jack Hampton's Permit Report.</u> Jimmy Church presented this report for Justyn. (See attached)

6. Codes Enforcement Report. Chris Pierce presented the report and power point presentation. Several properties show some improvement and others are now in compliance. Mr. Pearman questioned the status of the tires on Long Hollow

Road. Mr. Pierce stated that this is being worked and he is keeping a close eye on the situation. Mr. Pearman said that the laws regarding dumping of tires are changing in 2014. Mr. Steve Chambers asked about the April Greer property located on River Road in Valley Forge. Mr. Pierce stated it has been to court and bids taken for clean up. Mrs. Ingrid Deloach, Finance Director, and Mr. Schuettler will open them and award clean up to the lowest bidder in the near future.

7. <u>Director's Comments.</u> Mr. Church stated he had nothing further and asked Chairman Steve Pierce if he did. Chairman Pierce introduced Ms. Ronda Sawyer,

from FTDD, who will be attending our meetings each month.

8. Query. 1.) Billy Peters. Mr. Peters stood to address the commission and began by stating Mrs. Sawyer must not have noticed the sign that advised no drinks or food allowed. For this reason no one saw the need to tell Mrs. Sawyer to leave her drink outside the courtroom) Mr. Peters then asked about the number of certified state inspectors Carter County currently has. Mr. Church answered his questions. He then asked about the amount of money that has been turned into the state. Mr. Church answered this is a matter of public record and available for inspection at the office at any time. 2.) Roy Livingston. Mr. Livingston presented a "Freedom of Information" letter to the chairman asking for copies of all records pertaining to the former Ice House Saloon.
